

Litigation Update

NVLSP Issues FAQ for Veterans on Retroactive Combat-Related Special Compensation (CRSC) under Supreme Court Unanimous Ruling on Soto v. United States

On June 12, 2025, the U.S. Supreme Court <u>ruled</u> unanimously in favor of a class of over 9,000 disabled Army, Navy, Marine Corps, Air Force, and Coast Guard veterans who were wrongfully limited to six-years of retroactive Combat-Related Special Compensation (CRSC). The lead plaintiff in the case, Mr. Simon Soto, served in the United States Marine Corps from August 2000 to April 2006, with two tours of duty in Iraq where he searched for, recovered, and processed remains of war casualties. From his service, Mr. Soto was diagnosed with post-traumatic stress disorder (PTSD), was medically discharged, and awarded permanent medical disability retirement. In 2016, Mr. Soto applied for CRSC, which the Navy granted. However, the Navy limited its payment to Mr. Soto to only six years of retroactive pay, relying on a statute of limitations in a federal law called the Barring Act.



The Supreme Court unanimously held that there is no six-year cap on retroactive CRSC payments.
